## FAQS

### Who can participate?

- Open to all industry professionals under the age of 45, and/or those who seek leadership positions within their sponsoring company and the construction industry as a whole
- A company may enroll or sponsor as many eligible participants as it wishes
- Any person enrolling must have the support of the CEO/President of the sponsoring company and/or their direct supervisor/manager.

### What is the Cost?

- Annual participation fee is \$150 per year
- Fees cover the cost of meals, speakers, and registration of WYCA events

### How to Join?

- Sponsoring firm completes a nomination form for each participant and submits information to the Wyoming Contractors Association.

## **Defining the role of the WYCA Leadership Team**

The WYCA leadership team supports the Wyoming Young Contractors Association for the greater good of all members participating in the association.

The Leadership team is charged with the role of providing overall leadership and governance of the group to insure the vision and mission of the WYCA are carried out to the fullest extent to benefit all WYCA Members and their sponsoring companies.

WYCA's Leadership team will work together with WCA Chapter Staff to oversee the planning and successful execution of WYCA activities, WYCA member satisfaction and retention, and overall WYCA growth.

A WYCA Chair and Vice Chair are selected to serve one year terms to coincide with the Chapter's new Board President's election which takes place at the WCA Annual Convention each December. WYCA's Vice Chair automatically advances into the WYCA Chair's role for program continuity. The exiting Chair serves in an ex officio role for one year following their term and works closely with the current Chair and Vice Chair.

To remain a leadership team member in good standing, WYCA Chair members are expected to attend monthly meetings regularly, and participate in WYCA events (# TBD).

Service on the WYCA Leadership Team represents a powerful leadership development opportunity as team members gain knowledge and skills that can be used to enhance their personal and professional lives.
