REQUEST FOR BIDS 2021 SUBLETTE COUNTY CHIP SEAL PROJECT for SUBLETTE COUNTY, WYOMING Sealed BIDS are requested for work described in the Project Manual for the 2021 Sublette County Chip Seal Project, dated April 16, 2021, prepared by Rio Verde Engineering, 804 Hoback Street, P.O. The work consists of 300,000 SY of chip seal, 60,000 lbs. crack seal, 600,000 LF striping, and miscellaneous appurtenances. CONTRACTORS shall be required to accompany each BID with a BID Bond with sufficient surety, or a certified check, cashier's check or bank draft upon some reputable bank payable to Sublette County for at least ten (10) percent of the total amount of the BID. The BID Bond, draft or check shall be retained by Sublette County until proper bond to secure performance of the contract has been filed and approved. Bids INVITATION TO BID SUNDANCE KID TANK AND WATER LINE REPLACEMENT PROJECT Notice is hereby given that the City of Sundance (City), Wyoming will receive sealed bids for the furnishing of all labor, materials, tools, appliances, transportation, and services necessary for: Construction of a 199,000-gallon, glass-coated (or approved equal AWWA D103 coating system), bolted steel water storage tank with concrete foundation and associated ductile iron piping, appurtenances, grading, and security fencing; improvements within one existing pump

station including replacement of existing pumps, interior piping, valves and appurtenances with a new skid-mounted pump system; installation of approximately 2,600 linear feet (lf) of 10-inch poly-vinyl chloride (PVC) water transmission line through conventional trenching methods, approximately 15 lf of 8-inch PVC water transmission line, and 30 lf of 6-inch PVC water transmission line; approximately 820 lf of boring with 20-inch steel casing; demolition of two existing tanks (one above ground and one below ground); and all associated work to complete these services. Construction will include tank foundation and tank construction; grading; trench excavation; dewatering, pipe installation, bedding, backfill and compaction; installation of valves, pumps and appurtenances, traffic control, revegetation, and site restoration. These services are as called for in the Project Manual for the CITY OF SUNDANCE - SUNDANCE KID TANK AND WATER LINE REPLACEMENT PROJECT. Bids which are not prepared and filed in accordance with the Instructions to Bidders may be rejected. The City reserves the right to reject any bids and to waive irregularities in bids received. Each bid must be accompanied by a bid bond with sufficient surety for not less than five percent (5%) of the total amount of such bid, payable to, and to be forfeited to, the City of Sundance as liquidated damages if bidder fails to enter into contract within thirty (30) days after award to him, or fails, at the time of executing the agreement, to furnish a performance bond and a payment bond each in the amount of one hundred percent (100%) of the bid. Facsimile (fax) or other copies of bonds are not acceptable, nor are certified cashier's checks, certified checks or bank drafts. NO BID WILL BE CONSIDERED IF NOT ACCOMPANIED BY SUCH BOND OR IF NOT IN CONFORMANCE WITH THE PROVISIONS OF W.S. 15-1-113. Pursuant to W.S. 16-6-106, "preference is hereby given to materials, supplies, agricultural products, equipment, machinery and provisions produced, manufactured or grown in Wyoming, or supplied by a resident of the state, quality being equal to articles offered by competitors outside of the state". Qualified Disadvantaged Business Enterprises (DBEs) are encouraged to submit bids on this project. Bidders that use a subcontractor(s)/supplier(s) are required to make a good faith effort at soliciting DBE subcontractor/supplier participation. Bidders shall submit the required DBE Good Faith Effort Documentation form and other related forms with their bids. The procurement will be subject to the "Use of American Iron and Steel" requirements as contained in Section 436 of H.R. 3547, The Consolidated Appropriations Act, 2014 and as updated and revised in America's Water Infrastructure Act of 2018.
