REQUEST FOR BIDS Notice is hereby given that the Uinta County Conservation District (UCCD) is accepting bids for the Almy Ditch Project, a Bear River Restoration Project, to improve an irrigation diversion with a permanent structure and improve stability and reduce erosion and sediment loading in the Bear River by restoring approximately 1,975 feet of the Bear River located in Township 15N, Range 121W; 120W, Sections 1 and 6 north of the City of Evanston in southwest Wyoming. Sealed bids will be accepted until 2:00 pm on Wednesday, May 12, 2021 by the Uinta County Conservation District, 204 East Sage Street, P.O. Box 370, Lyman, WY 82937. Bids will be opened at the time they are due, and a decision to award the bid will be made at the UCCD board meeting on May 20th at 8pm. Bids Advertisement for Bids Street Surfacing Improvements City of Sundance The City of Sundance, Wyoming is accepting bids to pave and do minor street repair in the City of Sundance. Bids will be opened and read publicly at the city council room on April 22, 2021 at 3:00 p.m. The City Council will act on the bids at a later date. The work will consist of laying approximately 950 tons of asphalt paving overlay on existing pavement prior to June 15, 2021. An additional 1780 tons is planned for July 1, 2021 if funds allow. The project size may be adjusted to meet the funding available. The City of Sundance retains the right to select the bid that is most advantageous to the city and may reject any or all bids without cause. The Project includes the following Work: Street and utility improvements within the north and south limits of 3rd Street to 8th Street, as well as the eastern and western limits of Main Street to Diamond Avenue. These improvements involve the removal and replacement of water, sewer, and storm utilities

Bid Security A Bid must be accompanied by Bid security made payable to Owner in an amount of 5% percent of Bidder's maximum Bid price (determined by adding the base bid and all alternates) and in the form of a Bid bond issued by a surety meeting the requirements of Paragraph 6.01 of the General Conditions. Such Bid bond will be issued in the form included in the Bidding Documents. American Iron and Steel Section 746 of Title VII of the Consolidated Appropriations Act of 2017 (Division A - Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2017) and subsequent statutes mandating domestic preference applies an American Iron and Steel requirement to this project. Bidders that use a subcontractor(s)/supplier(s) are required to make a good faith effort at soliciting DBE subcontractor/supplier participation. Bidders shall submit the required DBE Good Faith Effort Documentation form and other related forms with their bids. Wyoming Preference Pursuant to W.S. 16-6-106, "preference is hereby given to materials, supplies, agricultural products, equipment, machinery and provisions produced, manufactured or grown in Wyoming, or supplied by a resident of the state, quality being equal to articles offered by the competitors outside of the state". Procurement Contract To Be Assigned Owner will execute a procurement contract for the procurement of goods for water and sewer line replacements, including water main pipe, valves, FH's, fittings and services lines; sewer main pipe, manholes and services in a portion of the phase 1 project limits. The materials and equipment to be provided through the procurement contract are to be furnished and delivered to the contractor's material storage area located at the Northwest corner of Thompson Street and 12th Street in Lusk, Wyoming 82225 for installation by Contractor. Contractor will take over responsibility of materials once delivered. Offloading will be the responsibility of the Contractor who is awarded the Lusk Phase 1 Streets and Utility Improvement Project. From this point forward the supplier for the procurement contract is no longer responsible for the protection of the materials and the contractor for the construction contract is now responsible.
